- Developing Countries Borrowed in Dollars

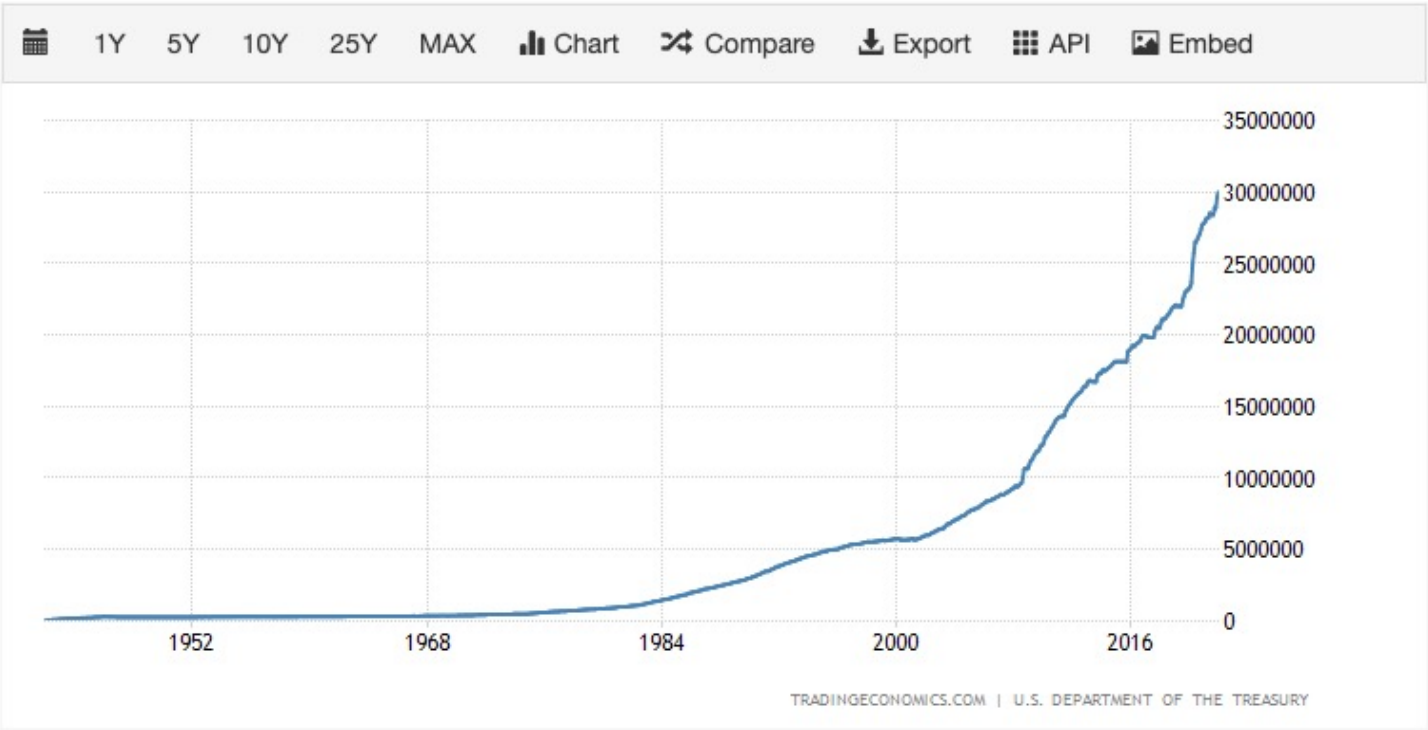

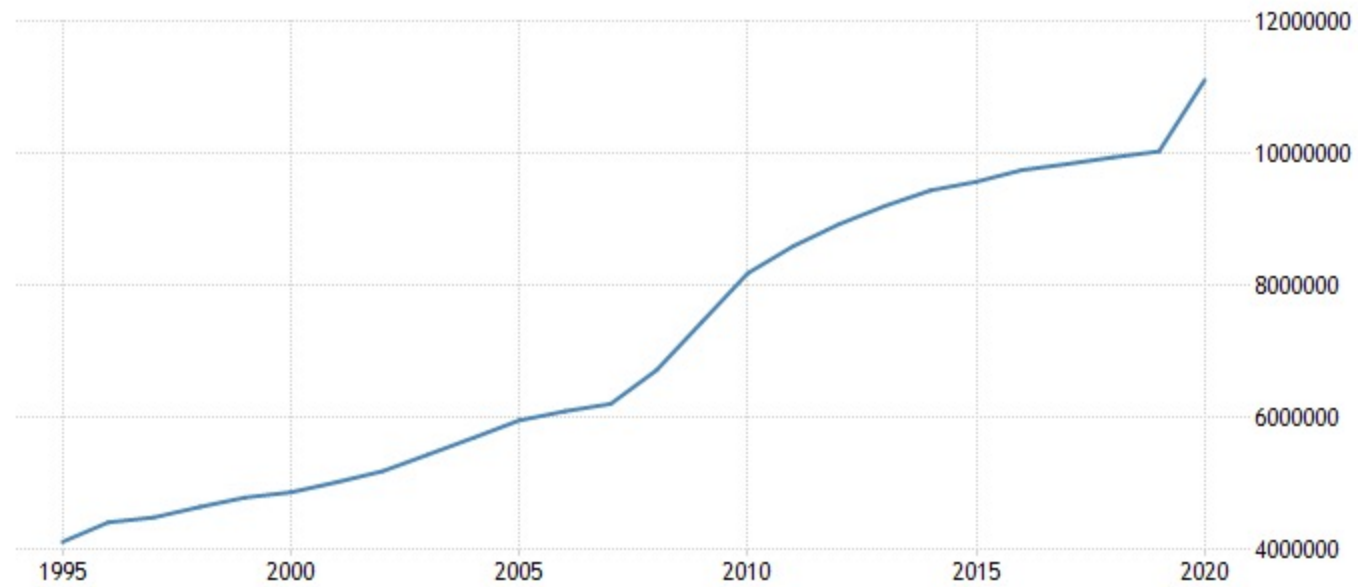

- Editors of NEJM, Lancet, and Ioannides Say 50% to 90% of Science Untrue

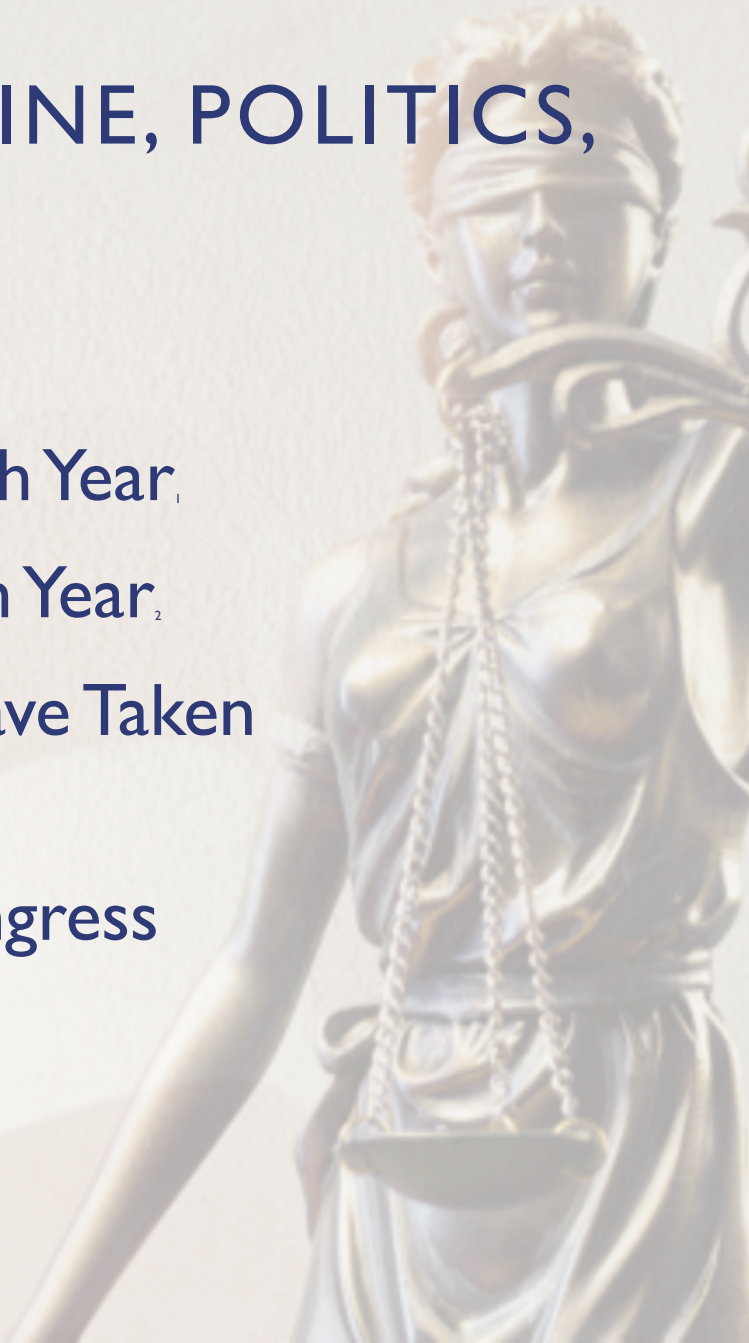

# PHARMA BUYS INFLUENCE – IN MEDICINE, POLITICS, AND MEDIA

- Pharma “Gives” \$30 Million to Congress Each Year<sub>1</sub>
- Pharma “Spends” \$250 Million Lobbying Each Year<sub>2</sub>
- 9 Out of 10 US Reps and 97 US Senators Have Taken Money from Pharma
- Twice as Many Lobbyists as Members of Congress

- Pharma Paid Doctors \$3 Billion in 2018 Unrelated to Research,<sup>1</sup>
- Pharma Funded \$750 Million (1/3) of Doctors CMEs In 2011.<sup>2</sup>
- Pharma Spent \$5.1 Billion on TV Ads in 2018.<sup>3</sup>
- Healthcare/Pharma Spent Est. \$35 Billion on Ads Globally 2020.<sup>4</sup>
- Healthcare/Pharma Est. \$10 Billion on US Digital Ads 2020.<sup>5</sup>

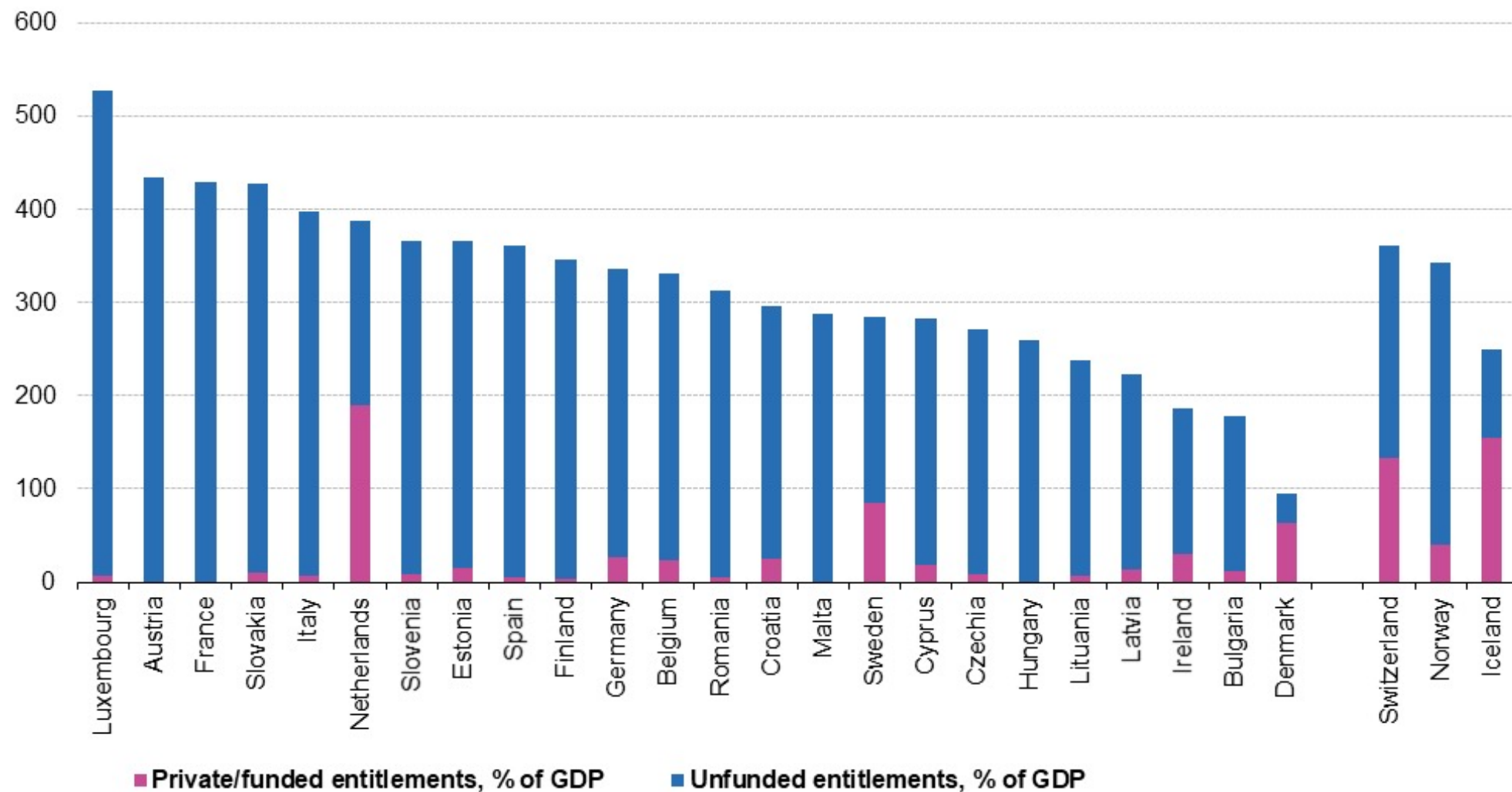

## SUMMARY OF TERRORISM THREAT TO THE U.S. HOMELAND – 07 FEBRUARY 2022

The United States remains in a heightened threat environment fueled by several factors, including an online environment filled with false or misleading narratives and conspiracy theories, and other forms of mis- dis- and mal-information<sup>1</sup> (MDM) introduced and/or amplified by foreign and domestic threat actors. These threat actors seek to exacerbate societal friction to sow discord and undermine public trust in government institutions to encourage unrest, which could potentially inspire acts of violence. Mass casualty attacks and other acts of targeted violence conducted by lone offenders and small groups acting in furtherance of ideological beliefs and/or personal grievances pose an ongoing threat to the nation.

For example, there is widespread online proliferation of false or misleading narratives regarding unsubstantiated widespread election fraud and COVID-19

(U) Domestic Violent Extremism Poses Heightened Threat in 2021  
01 March 2021

(U) The IC assesses that domestic violent extremists (DVEs) who are motivated by a range of ideologies and galvanized by recent political and societal events in the United States pose an elevated threat to the Homeland in 2021. Enduring DVE motivations pertaining to biases against minority populations and perceived government overreach will almost certainly continue to drive DVE radicalization and mobilization to violence. Newer sociopolitical developments—such as narratives of fraud in the recent general election, the emboldening impact of the violent breach of the US Capitol, conditions related to the COVID-19 pandemic, and conspiracy theories promoting violence—will almost certainly spur some DVEs to try to engage in violence this year.

- NEJM Study – 10 NC Hospitals, 2002-2007<sup>1,2</sup>
- 18% of Hospital Patients Harmed by Medical Care
- In 2.5% of Cases Patient Died
- 3% Injuries Permanent
- 8% Of Admissions Experienced Life-threatening Issue

- 1.3 Million ER Visits from Adverse Drug Events and 350,000 Subsequent Hospitalizations<sub>2</sub>
- 40,000 Medical Errors EVERY Day<sub>3</sub>

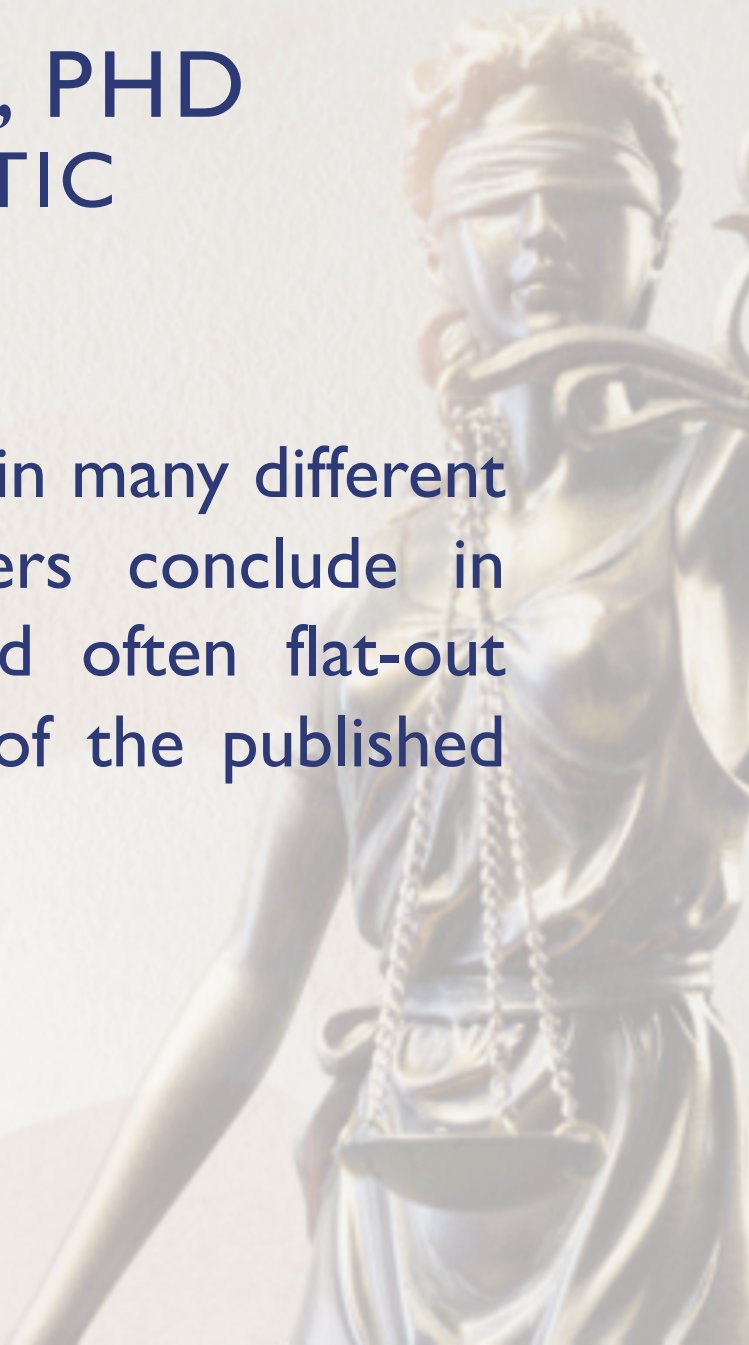
